FROM THE PRESIDENT

Returning from the State and National MOAA Annual meetings, it is sometimes difficult to determine what we got out of them. But, perhaps that is the wrong question.

What did we do during the year to make our Chapter, Council, and National organization viable to our members, our Armed Forces, and Community? One measure of that is the annual review of our Chapter that I make in the submission for the Level Of Excellence (LOE) Award. Those submissions are reviewed by a panel of three judges. Our Chapter has been chosen for the Five Star Award for the last four years. Less than 25% of the 413 Chapters receive that designation. You can be justly proud of your accomplishment, but a lot more needs to be done in our community. The LOE Awards are given on the first day of the National meeting. The second day's dinner recognized the Community Heroes Award recipients. These

ranged from Senator Elizabeth Dole, who started a foundation, Caring for Military Families, to a 25 year old former Marine Corps sergeant who has dedicated himself to increasing awareness of veteran's struggles and their incredible strength. To garner funds for his campaign he ran 3600 miles from California to Maine from Veterans Day 2012 to Veterans Day 2013, attracting some \$500,000 which he has donated to three charities that support veterans. In the group category, I was amazed at the use of technology at the Walter Reed National Military Medical Center's 3D Medical Applications Center. They use 3D technology to fabricate titanium craniofacial prosthesis for those suffering from polytraumatic injuries. I mention these only as a means to give visibility to the dedication by many to our wounded heroes.

MOAA's President and CEO, VADM Ryan's annual report was again inspirational and motivational. You might ask how can such a dry subject have that effect on the audience? I'll let you be the judge of that, his address is on the MOAA web site, on the home page, click on 2014 Annual Meeting, then click on the second bullet 2014 Annual Meeting. He recounted the accomplishments for 2013-14 and the challenges that lie ahead for 2015.

Membership is at the top of the list and has two elements. The raw number of 390,000 members is key to his and his staff's access to the executive and legislative branches. This was exemplified when the Director of Government Relations, Col Mike Hayden, was unexpectedly called out of a meeting to appear and testify before the Commission studying military compensation. The second part of membership is the 'Boots on the ground' Chapter members who are engaged in meeting, calling or writing their local Federal representatives on MOAA legislative issues. This part is essential to our National leadership's work and solidifies the basis for their work. And, the Boots vote.

Sequestration is the 900 lb. gorilla in the room for 2015. While given budget relief for 2013 and 2014, it will be in force for 2015, meaning a military budget reduction of 10% (excepting for a few programs). This is all done in light of new initiatives using our All-Volunteer force. It all boils down to that force being driven by a budget number rather than an overall national strategy. Restoration of full COLA for our active duty, reversal of the proposed 5% reduction in Basic Housing Allowance, and abiding by the previous agreement on TRICARE increases round out MOAA's focus for legislative action.

ADM Ryan shared that it was getting harder and harder to develop a relationship with some of the 80% of the legislators who, as a group, have not served in the military and their young staffers. He pointed out that he expected little to be accomplished during the lame duck session before the Holiday break and, on top of that, the election may require subsequent 'run-offs' which could delay setting the legislature for the next session.

And last but certainly not least, a sincere thank you to our Vice President, Lt Col Norma Weissend for chairing the General and Board Meetings so that Rosemary and I could attend the MOAA Annual meeting and spend some time with our daughter who lives in Virginia.

Veterans Day. Please observe this day in a public venue. It is a day in which Americans honor and pay tribute to those who are serving and who have served. Be present and visible to our communities, so that our service and sacrifices are not forgotten. LTC Russ Green and I will place the GVC/MOAA wreath at the War Memorial at 11 AM on that day.

VAMC Gift Wrap. Please join the Spouses Club at 1 PM on December 11th at the Canandaigua VAMC to wrap gifts for VAMC patients. It is one way of showing our concern and holiday wish for their healing on a sometimes lonely journey. The group wraps over 1000 presents in about two and a half hours. We normally have lunch at the Rheinblick Restaurant prior to the wrap. See the Spouses Club article for details.

Dues. 2015 dues are to be paid prior to January 1st as stated in our By-Laws. They are at a bargain rate of \$15/Year prior to that date and \$20 thereafter. Pay for two years at the \$15 rate or, better yet, become a Chapter Life member at the lower rate.

Chapter Holiday Dinner. Bring a small gift, your dancing shoes and make reservations for our Annual Holiday Dinner, this year at the Burgundy Basin on December 7th. All the Army officers will not have to worry this year about your president wearing his Navy sweatshirt as the Army - Navy game isn't until December 13th.

Rosemary and I ask that you consider sharing your bountiful harvest with those not so fortunate and wish that you experience the peace, joy and blessings of the season. I would also ask that you keep our deployed troops and their families in your thoughts and prayers.

Chapter Elections. (Repeat) I have assigned Dave Szczygiel, as the Chairman of the Nominating Committee for the elections next June. Not that I am in a hurry or anything, but experience has shown that this process takes a while for members to step forward or, be encouraged to do so, obtain information on the

position, and make a decision. We have a great organization, but it will only remain so if members step forward and volunteer as some of our currently serving Board members and officers step aside.
