FROM THE PRESIDENT

October 1, 2015 has turned out to be a big day! It is the start of the Federal government's new fiscal year, amidst turmoil and again without a budget in place; anticipation for increases in TRICARE premiums as well as pharmacy copays; and it signaled the dawning of new, grave concerns in the Middle East.

The heated budget argument on both sides of the aisle in both the Senate and the House is very disappointing, and infuriating, to many Americans. For those of us very concerned with the Armed Forces and its funding, it is looking **ER STOP SERVING** *** **OCTOBER 2015** dismal. It seems like our legislative goals are being completely ignored.

For the 3rd year in a row, the White House, using Executive Authority, has capped the active duty

pay raise well below the 2.3% required by law. The troops' last four raises averaged less than 1.4 percent, with FY14 and FY15 pay raises being the lowest in 50 years. Former MOAA Director of Government Relations, Col Mike Havden. USAF (Ret) expressed his disappointment for all of us. "Past experience with capping military raises below private sector pay growth has shown that once pay raise caps begin," he said, "they continue until they undermine retention and readiness of the allvolunteer force."

Active duty and retiree benefits are not being protected by legislators who are not supporting changes that are more consistent with service career sacrifices. VA is a whole topic of its own, and now, especially in light of the greatly changing dynamics in Syria, Israel and the fight against ISIS in just the last few days, I believe there is real danger that the sizes and funding for active duty, Guard, and Reserve forces are not enough to meet mission requirements.

U.S. lawmakers agreed to increase pharmacy co-pays that largely affect military retirees as part of a sweeping defense bill. As of October 1, 2015, a new law requires all TRICARE beneficiaries, except active duty service members, to get select brand name maintenance drugs through either TRICARE Pharmacy Home Delivery or from a military pharmacy. Beneficiaries who keep using a retail pharmacy for these drugs will have to pay the full cost. http://www.tricare.mil/RxNewRules

<u>AUXILIARY MEMBERSHIP</u>: (repeat article) There still may be some confusion regarding the membership status of Auxiliary members. Let us start out by defining some terms.

- An Auxiliary member is the surviving spouse of a deceased MOAA and/or Genesee Valley Chapter member. (In fact, MOAA National, for whatever reason, has chosen to stop using the term "Auxiliary" in favor of "Surviving Spouses".)
- A "Life Member" can be either a Life Member with MOAA National or Genesee Valley Chapter or both. (Most GVC PAID Life Members are also MOAA National Life Members, however the reverse is not necessarily true.)

With the above definitions in mind, let's recall that a couple years ago, MOAA National directed that Auxiliary members be eligible for full membership in MOAA National as well as all chapters. Full membership includes the right to vote and the right to hold any chapter office. Furthermore, they said that any Auxiliary member whose spouse was a Life Member, inherits that Life Membership. We instituted that same policy here at the chapter level as well. Any Auxiliary member whose spouse was a Life Member of either MOAA National OR GVC is considered a Life Member of the Chapter. So what if your spouse was not a life member of either MOAA National or GVC?

Here are your options:

• You can become a dues-paying member of the chapter. GVC membership dues

are \$20 per year, which entitles you to all the rights of membership, to include voting rights, and the right to be elected to an office and the Board of Directors.

- You can forgo full chapter membership and join the Spouses' Club. Their dues are currently \$10 per year, which entitles you to take part in their activities and hold an office in the Spouses' Club.
- You can choose not to join EITHER organization, but continue to receive our newsletters and attend our dinners as long as you wish. This is a courtesy we've always extended to surviving spouses, and we see no reason to change that policy.
- Finally, you can decide you no longer wish to belong, and no longer wish to receive our newsletter. We certainly hope none of you choose this option. We don't want to lose you!

I served on active duty for 24 years in the United States Navy as a Nurse Corps Officer retiring in 2004 at the rank of Captain. I helped to develop and expand the role of the Fleet Family Nurse Practitioner. During one tour in Norfolk, Virginia, I worked on 40 "small boys" ships providing medical support, training, and care coordination at the pier and during short deployments. Currently, Ι am the Associate Chief Nurse for Ambulatory Care at the Canandaigua VA. I supervise over 60 VA nurses. which includes staff from the Canandaigua Outpatient Clinic, Rochester Outpatient Clinic, Home Based Primary Care Program, and Home Telehealth Program. It is very important that we continue to support our veterans who put their lives on the line to keep the torch of freedom burning for all.

GVC AUXILIARY: THE SURVIVING SPOUSES OF MOAA:

This year, MOAA is launching a new publication, **The Survivor's Guide.** Its purpose is to assist surviving spouses after their loved one's death. Similar to a worksheet, the guide includes places to record funeral arrangements, lawyers, insurance contacts, and more. Also telephone numbers of federal agencies that can assist the survivor are listed IE. Social Security Administration, Defense and Finance and Accounting Services, etc.

It is suggested that both spouses work together to fill in the information before it is needed. Although the guide does not replace other methods of record keeping, it is different because it includes information on both military and civilian agencies.

When available, it will be in print and as a download from the MOAA website (<u>www.moaa.org/infoexchange</u>). Until it is available, MOAA members can refer to the shorter **Survivor's Checklist: First Steps to Moving On** available from MOAA.

I will continue to monitor MOAA website for the guide's availability.
