From the President

It is with heavy heart that I again report the death of a valued member. This time it is Col Edwin "Woody" Mench, USAF (Ret) after his long and courageous struggle with illness. Woody's name and Genesee Valley Chapter are almost interchangeable. He served as Chapter President, NYS Council of Chapters President and governing Board member of both organizations. In addition, he was a 'Plank Owner' of Honor Flight Rochester, serving as Treasurer and President. He was always there to offer counsel and encouragement and willing to try something different. His mere presence at various events brought a spark that called us to do more and do it better for our membership and our service men and women in uniform. Personally, he was a mentor and the finest example of what it means to be a servant leader in our Chapter. Our thoughts and prayers go out to Marion and the family at this time of great sadness.

Federal Legislation. From the MOAA Weekly Update dated November 8, 2013. **Debt Ceiling/Sequestration.** When Congress passed legislation on October 16th to raise the debt ceiling and end the government shutdown it also agreed to establish a new joint committee to work on a budget and address sequestration and deficit reduction. The new bicameral committee's deadline is December 13 but, like many of its predecessors – including the 2011 "Super Committee" – it could fail to deliver a significant proposal. The new joint committee is distancing itself from previous endeavors by lowering expectations. Rep. Paul Ryan (R-Wis.) stated "if we focused on doing some big grand bargain, like those prior efforts...then I don't think we'll be successful because we'll focus on our differences ...each party will demand that the other compromises a core principle, and then we'll get nothing done."

Senator Harry Reid (D-Nev.) referred to the idea of striking a grand bargain as "happy talk." The 29 committee members met for the first time on October 30 and the conferees agreed to work towards a modest agreement that would establish discretionary spending levels for FY 2014 and secure some relief from sequester-driven spending cuts in January 2014.

The committee reconvened for a second time on November 6.

While tax rate hikes are likely off the table, the committee may look to end some tax exemptions and close loopholes.

Modest entitlement reforms and spending cuts are other topics that may emerge in the coming weeks as both sides try to hammer out an agreement.

The December 13 deadline is fast approaching. Expectations are low, but the memory of the shutdown and debt ceiling crisis of October may spur Congress to take action.

'Doc fix'.

- The House Ways and Means and Senate Finance Committees are working together on bipartisan legislation that aims to finally repeal and replace the flawed Medicare/TRICARE physician reimbursement rate.
- Current law calls for a 24 percent cut in Medicare/TRICARE reimbursement rates to doctors on January 1. Allowing such a large cut to take place would devastate access

- to care for beneficiaries.
- For years Congress has passed patchwork legislation to block these cuts, kicking the can from one year to the next year. The annual cycle of uncertainty wreaks havoc on physicians participating in Medicare and TRICARE, and threatens access to care for millions of beneficiaries.
- The proposed permanent fix would repeal the Sustainable Growth Rate that drives the annual cuts. It would replace it with a ten-year freeze of physician reimbursement rates at current levels. It would also seek to boost efficiency in the health care system by incentivizing physicians to use alternative payment models that focus more on value than volume.
- Starting in 2024 doctors participating in fee for service plans would see a negative 1
 percent annual adjustment, and those using more efficient alternative payment
 methods would see a 2 percent increase.
- The plan would also offer payments for care coordination, value-based reporting systems and meaningful use of electronic health records. Under the proposal, doctors would be held to accountability standards for quality and resource utilization.
- Physician stakeholder groups have until November 12th to respond to the draft proposal.
- The total cost of the legislation is roughly \$139 billion. Although it's far less expensive than previous proposals, the challenge for Congress is coming up with the offsets to pay for it and convincing physicians to agree to a ten year pay freeze.

It is important to 'weigh in' on these and other issues that affect our lives and the benefits that we receive that have been earned by the dedicated service to our Country. I ask that you take a few minutes to keep abreast of the current issues and make your voice heard. The following is a suggested and effective method to make your voice heard by your elected officials.

Email

Go to moaa.org, click on 'Take Action' on the Home page in the upper left hand corner. If you want to receive weekly updates on the important issues, go to 'Weekly Legislative Update' and subscribe with your email address. MOAA will send you a short bulletin on active Bills on a weekly basis with the opportunity to send a scripted email to your senators and representative.

If you don't want to subscribe, but wish to send an email on a specific issue, go to 'Key Bills', find the bill number, click on it and send a scripted email to your senators and representative. You can get a 'Two for' by previewing the scripted email before sending it, copying it and pasting it on a blank Word document and send it to the local office listed below.

Personal Affairs - ANNUAL CERTIFICATION OF ELIGIBILITY (COE)

Effective Aug. 1, 2013, most Survivor Benefit Plan annuitants over the age of 55 are no longer required to complete and submit an annual Certificate of Eligibility to the Defense Finance and Accounting Service. Annuitants should no longer expect to receive the annual COE once they reach age 55. Their eligibility to receive annuity payments will continue without submitting the COE.

The following annuitants will continue to receive annual COEs and must submit their completed forms to DFAS to continue annuity payment eligibility:

- Annuitants under 55 years of age
- Annuitants who are receiving hard copy checks in a foreign country (regardless of age)
- Annuitants who have a permanent disability (regardless of age)

DFAS will send you an annual reminder when your COE is due. Please be sure to notify them if you move, so that you will continue to receive these important notices and reminders.
