2013 Reflections, The end of the year gave me the opportunity to relax and reflect on the year. As host Chapter of the Council Convention, we did a fantastic job in planning and executing our vision for that event, but at a cost of physical and emotional stress mixed with the satisfaction of a job well done. An unexpected outcome was the request from the MOAA Assistant Director of Council and Chapter Affairs to provide his office with the planning guide we used for the Convention. Their idea was to get the best ideas from host chapters around the country for a MOAA guide for those states who do not hold

conventions on a regular basis. Since I had all the information, I also submitted the guide for a MOAA Communications Award. I plan to provide the guide to next year's convention host Chapter, the Southern Tier. The time also gave me a chance to reflect on those who have passed from our midst, who served in leadership roles and were my mentors during the short time that I have been a Chapter member. Col Woody Mench and Col Phil Tierney contributed much to the Council and Chapter and will be greatly missed.

2014 / Membership, It's a new year and we get to do it all over again . . . not so fast! When I became a commanding officer, I got some old Navy sage advice, "Don't steer by your wake or you will put this thing on a reef or run into somebody". Since membership is our lifeblood, we have to stay focused on new Chapter members and retention. That is the pointy end of the organization and we all need to understand that we are all recruiters and retainers of the Chapter and the legacy it will leave behind. I think we did well last year, 7 new members and one conversion to Life Membership. But our losses prevented us from attaining a MOAA 90% retention rate goal. Some of this had to do with administrative bean counting, but some was not. We want to work on what was not. We are off to a good start this year with two Life Membership conversions, COL Peter Ingalsbe and LtCol Norma Weissend. Thank you and welcome.

I think we are sometimes frightened when the officer asks the question, "Why should I belong"? or "What's in it for me"? There are at least two answers to those questions. First, From a financial or quality-of-life standpoint, our earned

benefits are rooted in bills enacted in the Congress and signed into law by the President. Likewise, changes to those laws follow the same route. The power of an organization such as MOAA and its 375,000 members provides a voice and information on bills before the Congress. Remember, only about 20% of those members have served in the military. With rare exception, an individual does not have the same influence on legislation. MOAA has 10 registered lobbyists, all retired officers, with one being VADM Ryan, to do this job. The **second** reason is more philosophical. My family and I enjoy the earned benefits today due to those who came before me and worked so hard for those who were serving. **So pay it forward**, and become involved in an organization that works on those issues, so they will be available for future military. If you don't, who will?

Federal Legislation, Over the past two months, several pieces of Federal legislation affecting the military have been brought before the Congress in order to beat certain budget deadlines. MOAA has asked that you weigh in on these issues by emailing your concerns to your congressman and senators. On the COLA issue alone, MOAA members sent over 295,000 messages over the past two months. Through these efforts and the MOAA and the Military Coalition staff, they did listen and on Tuesday and Wednesday, February 11th and 12th, Congress approved legislation to repeal the COLA cuts for military retirees under age 62 and the currently serving. During a Senate Armed Services Committee hearing on the COLA cuts for working-age military retirees established in the Bipartisan Budget Act of

2013 (BBA), Pentagon witnesses repeatedly talked about curbing military personnel costs. It became crystal clear the Pentagon does not intend to wait until the Military Compensation and Retirement Modernization Commission's (MCRMC) completes its review in February 2015 to start adjusting currently serving compensation and benefit programs. They will introduce changes in the 2015 budget due to be submitted on March 4th. From the perspective of MOAA's Director of Government Relations, Col Mike Hayden, the gains over the past 13 years are now targets for cuts with the following forms of pay and benefits being leading candidates. These, and maybe more, are facing the chopping block. More clarity will surface once the budget rolls out March 4.

- Capping pay raises or even freezing pay;
- Making additional end-strength cuts;
- Changing basic allowance for housing to make service members assume more of the costs;
- reducing the commissary benefit savings; and
- means-testing TRICARE fees and establishing TRICARE For Life /TRICARE Standard enrollment fees.

The bottom line: The Pentagon will push pay and benefit cuts, and they will be more than "tweaks." These proposed changes will definitely impact the purchasing power of military families.

New York State Legislation, Legislation for the Interstate Compact on Educational Opportunities for Military Children has been sponsored in the NYS Senate and Assembly since 2008. The latest bills are

S.1213 and A.5787. This legislation would make the State a member of a Compact focused on alleviating many of the academic challenges posed by different state educational systems that the children in military families face when moving from state to state. Between 1/3 and 1/2 of the 14,000 school-age children of active duty military families who reside in NY because of military orders transfer in and out of our state every year. This is disruptive enough without having to deal with overly bureaucratic barriers to their successful transition and fulfillment of educational goals. New York State now has the largest population of school-aged children of active duty service members in the 4 states that are NOT members of this Compact. While the Senate has passed their version unanimously for the last three years, the Assembly Bill has not made it out of the Education Committee each legislative session since 2008. We must press Assembly members in our Districts that are on the Education Committee to hold hearings on A.5787.

Personal Affairs/TFL As part of the 2013 National Defense Authorization Act, all TFL beneficiaries must enroll in home delivery through Express Scripts for maintenance medications and remain in the program for one year, after which beneficiaries may opt out of the program. Express Scripts may issue individual waivers on a case-by-case basis. Nursing home patients and those who use a military treatment facility are exempt. Enrollment begins February 14th and may be done either online or by calling Express Scripts at (877) 363-1303.

March Meeting, We will again feature the local College and University ROTC/NROTC

programs in the Rochester area. The Chapter will honor the outstanding ROTC/NROTC Cadets and Midshipmen from the University of Rochester, Rochester Institute of Technology and SUNY Brockport with the MOAA Medal. Several Chapter members commented last year on the enthusiasm of these young men and women who have shown a strong sense of dedication, patriotism and commitment to serve our nation as a part of the All Volunteer Force. The Cadets and Midshipmen commented on the feeling of acceptance and camaraderie of the Chapter that continues to serve a new generation of officers long after they have left active service. The Cadre at these units appreciated the opportunity to talk to veterans from different military services and specialties represented in our Chapter. The Cadre and honored Cadets from the two JROTC programs will be included in the program. The MOAA scholarship recipients and their parents have also been invited. Again this year the Chapter has been successful in obtaining a grant from USAA to partially offset the cost of this event. This is a unique opportunity to meet and mingle with the future military leaders. Don't miss it, details are on the last two pages of the Newsletter.

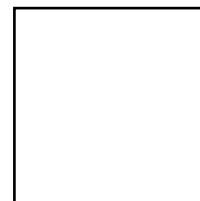
