MOAA Legislative Issues for 2019; obtained from the MOAA website.

"In 2019, MOAA Government Relations will engage the 116th Congress early and often on issues of greatest importance to our members, the men and women in our uniformed services, their families, and their survivors," says Col. Dan Merry, USAF (Ret), vice president of Government Relations. "As military experience among members of Congress has declined over the years, with just over 17 percent having experience in uniform at the onset of 2019, these goals are instrumental to our efforts to inform and influence members of Congress and their staffs." Ten stated goals are as follows;

The Goal: Ensure any TRICARE reform sustains access to top-quality care.

Prevent disproportional TRICARE fee increases

Sustain military pay comparability with the private sector

Stop erosion of compensation and non-pay quality-of-life benefits

End financial penalties for military survivors

**End concurrent receipt penalties for military retirees** 

Achieve equity of benefits for Guard and Reserve members with their active duty counterparts

Strengthen DoD-VA collaboration and services to support wounded warriors and an expanding population of women veterans

Ensure timely access to service-earned VA benefits and lastly

Protect military and veteran family support programs and policies.


