FY 2020 NDAA Highlights

Big, big news, and frankly, it's much overdue... the FY 2020 National Defense Authorization Act eliminated the Survivor Benefit Plan-Dependency Indemnity Compensation (SBP-DIC) offset or what is referred to as the Widows Tax... however... the elimination will be phased in over three years, beginning in 2021 and increasing incrementally until spouses receive 100% of both their SBP and DIC benefits in 2023. MOAA¢s relentless advocacy and pursuit in this regard paid off and the MOAA staff deserve kudos for their monumental accomplishment!

This too is huge... also included in the FY 2020 NDAA, was the establishment of our Nation's newest and sixth branch of the armed forces... welcome United States Space Force (USSF)! The USSF was established within the Department of the Air Force and will be stood up over the next 18 months and will have a four-start general, known as the Chief of Space Operations (CSO), who serves as the

senior member of the USSF and is also a member of the Joint Chiefs of Staff.

And the FY 2020 NDAA directly affects your pocketbook if you use TRICARE. Enrollment fees, Retail and Mail-order Pharmacy fees have increased.

Enrollment fees for retirees who entered service prior to Jan. 1, 2018. TRICARE Prime: \$300 (single)/\$600 (family), up from \$297/\$594; TRICARE Select: No fee.

Enrollment fees for retirees who entered service after Jan. 1, 2018. TRICARE Prime: \$366 (single)/\$732 (family), up from \$360/\$720; TRICARE Select: \$471 (single)/\$942 (family), up from \$462/\$924.

Retail pharmacy fees. \$13 for 30-day supply of generic, \$33 for brand name, \$60 for nonformulary (up from \$11, \$28, and \$53, respectively).

Mail-order pharmacy fees: \$10 for a 90-day supply of generic, \$29 for brand name, \$60 for non-formulary (up from \$7, \$24 and \$53, respectively).

Note: No fees for 30-day supplies for generic and brand-name drugs from military treatment facilities (MTFs). However, take note of the story below, access to MTFs may disappear.

And one bright spot in this area... There were no TRICARE For Life enrollment fees or deductibles in 2020.

In MOAA Newsí Military Medical Facilities Will Stop Treating Families, Retirees. This may not apply locally, but if you snowbird near Military Treatment Facilities, you could potentially be affected. This is fallout from the FY 2017 NDAA, which directed the focus of the Military Health System to be on readiness. Letter to President Trump From Veterans Groups Seeks Addition of 4 Presumptive Diseases to Agent Orange List

Seven veterans service organizations (VSOs) have united to call on President Donald Trump to use his executive powers and add four scientifically connected presumptive diseases to the list of veteransø diseases associated with Agent Orange.

MOAA co-signed the letter with the Disabled American Veterans, Veterans of Foreign Wars, Vietnam Veterans of America, Fleet Reserve Association, Paralyzed Veterans of America, and AMVETS following the VA notification that the department would await the results of two studies that are scheduled to be released in late 2020 before making any changes to the list of presumptive conditions.

The four presumptives -- bladder cancer, hypothyroidism, Parkinson-like symptoms, and hypertension -- affect at least an estimated 83,000 veterans.
